OURSELVES THAT THOUGH PROHIBITIONS MAY WELL EXIST, VIOLATIONS OF THESE PROHIBITION EXIST AS WELL.

THE LOWEST PERCENTAGES OF STRAW HAVE BEEN COLLECTED IN SOFIA, RAZGRAD, BURGAS, AND MIKHAYLOVGRAD OBLASTS (BETWEEN 36 AND 45 PERCENT). MARKED DIFFERENCES CAN BE NOTED IN THE WAY THE DIFFERENT MUNICIPALITIES ARE CARRYING OUT THIS AGRICULTURAL TASK. WHEREAS A FEW DAYS AGO VELIKO TURNOVO MUNICIPALITY HAD COMPLETED 97 PERCENT OF THIS TASK, AND LOM MUNICIPALITY HAD COLLECTED THE STRAW FROM 86 PERCENT OF THE HARVESTED FIELDS, MIKHAYLOVGRAD MUNICIPALITY HAD ONLY COMPLETED ONE-THIRD OF THE WORK.

OF COURSE, OBJECTIVE REASONS DO EXIST. LARGE AMOUNTS OF STRAW LEFT OVER FROM LAST YEAR CAN BE SEEN, AND VILLAGE FARMERS ARE REFRAINING FROM COLLECTING AND BALING THE STRAW IN ORDER TO AVOID EXCESS EXPENDITURES (WHICH ARE NOT INSIGNIFICANT). HOWEVER, THE TRUE FARMER FINDS A WAY OUT, FOR EXAMPLE BY DISTRIBUTING UNLIMITED AMOUNTS OF STRAW TO PRIVATE FARMERS, OR BALING IT TO KEEP IT IN RESERVE FOR THE NEEDS OF STOCKBREEDING AND VEGETABLE PRODUCTION.

EVERY SOLUTION IS GOOD IN ITS OWN WAY, BUT ONE IS ABSOLUTELY UNACCEPTABLE, AND THAT IS BURNING!

WITHOUT MENTIONING THE DANGER PRESENTED BY STUBBLE BURNING, AND WITHOUT CONSIDERING IN DETAIL THE LOSSES, WHICH CAN VERY EASILY MULTIPLY (AS SUCH MATTERS ARE CLEAR TO EVERYONE), LET US REMIND OUTSELVES OF THE EXTREMELY UNFAVORABLE ECOLOGICAL CONSEQUENCES.
